1. Choose the phillips head screw (fig.1 A) for an adjustable installation -or- choose one-way security screw (fig.1 B) for a permanent installation.* (*suggested to test fit with phillips screws prior to using security screws.)

2. Insert desired mounting screws with flat washers through the corresponding base mounting holes. Use qty.1 Raptor Standoff™ 0.5in (shown) if mounting with a Raptor Barrel Bracket™ and Raptor Buffer Mount™. Then thread the T-Nuts on the mounting screws leaving the T-Nuts loose. (fig. 2)

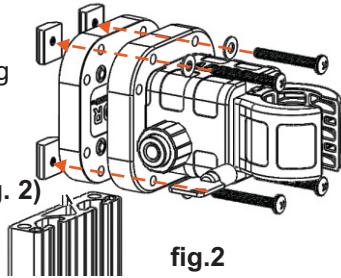

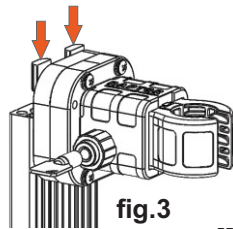

3. Slide the Raptor Standoff™ & Raptor Buffer Mount™ on to the Raptor Rail™ aligning the T-Nuts to fit into the rail grooves. (fig. 3)

4. Position the Raptor Standoff™ & Raptor Buffer Mount™ to the desired location. Lightly tighten mounting screws to hold the bracket in place while still allowing for adjustment. (fig. 4)

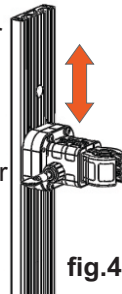

5. Install a Raptor Barrel Bracket™ or Raptor Picatinny Mount™ to complete your configuration. Instructions are included with all Raptor Mounts™ or available online @ usaraptor.com (fig. 5)

6. Test fit your weapon and adjust the Raptor Buffer Mount™ and Raptor Brackets™ for best fit. (fig. 6)

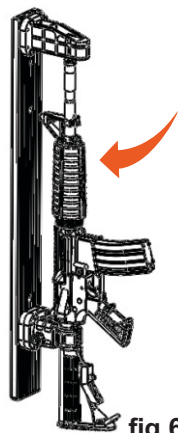

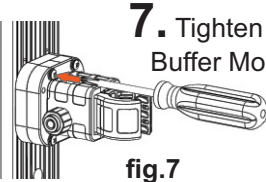

7. Tighten the mounting screws on the Raptor Buffer Mount™ and Raptor Brackets™ by hand with a #2 phillips screw driver or a standard flat blade if using the one-way security screws. (fig. 7)
